 IN 2025, CLC'S LEGAL CARE PROGRAM (LCP), OUR LARGEST COMBINED PROGRAM, PROVIDED FREE LEGAL SERVICES TO A TOTAL OF 647 MINNESOTANS WHO HAD A COMBINED 858 DIFFERENT LEGAL MATTERS; MAINTAINING THE 20+% GROWTH IN CLIENTS SINCE 2023. THE BIGGEST AREAS OF NEEDED LEGAL CARE WERE SOCIAL SECURITY DISABILITY INSURANCE, ESTATE PLANNING, AND INSURANCE COVERAGE ISSUES. AS HAS BEEN THE TREND FOR THE LAST FEW YEARS, A GROWING NUMBER OF CLIENTS HAVE STAGE IV CANCER. IN 2015, 26% OF OUR CLIENTS WERE STAGE IV. IN 2025, 52% OF OUR CLIENTS WERE LIVING WITH STAGE IV CANCER.

THE LCP IS DESIGNED TO HELP OUR CLIENTS MAINTAIN FINANCIAL SECURITY AND FAMILY STABILITY EFFECTIVELY AND EFFICIENTLY. THE FOLLOWING IS A BREAKDOWN OF CLIENT'S LEGAL NEEDS AND AREAS OF LEGAL CARE PROVIDED:

 ICARE - A SIGNIFICANT EXPANSION OF OUR WORK TOOK PLACE IN 2020 WITH THE CREATION OF OUR ICARE PROGRAM UNDER THE UMBRELLA OF OUR LEGAL CARE PROGRAM OFFERINGS. ICARE (INSURANCE CLAIM ADVOCACY AND RESOLUTION) ADDRESSES THE GROWING NUMBER OF HEALTH INSURANCE COVERAGE DENIALS DUE TO MANY FACTORS INCLUDING SHRINKING NETWORKS AND EVER-CHANGING PRE-AUTHORIZATION REQUIREMENTS. OUR GOAL WITH ICARE IS TO MAKE A SIGNIFICANT IMPACT ON THE HEALTH AND FINANCIAL WELL-BEING OF OUR CLIENTS BY WAY OF ENSURING THAT THEIR INSURANCE COVERS WHAT IT SHOULD, AND THAT HOSPITAL BILLING AND CODING ERRORS ARE CORRECTED SO THAT OUR CLIENTS ARE NOT RESPONSIBLE FOR BILLS THAT ARE NOT THEIRS TO PAY. SINCE PILOTING THIS WORK IN 2019, WE HAVE CLOSED 176 COMPLICATED INSURANCE MATTERS WITH A 94% SUCCESS RATE FOR OUR CLIENTS. OF THESE

WHEN THIS PROGRAM STARTED IN JANUARY 2023, OUR WORK FOCUSED ON COMPLETING SOCIAL SECURITY DISABILITY BENEFIT (EITHER SSDI OR SSI) APPLICATIONS ON BEHALF OF CANCER PATIENTS. IN 2024, THE AVERAGE AGE OF A CLC CLIENT WAS 53. CANCER SURVIVORS ARE 2.5 TIMES MORE LIKELY TO FILE FOR BANKRUPTCY THAN PEOPLE WITHOUT CANCER, AND THOSE CANCER SURVIVORS WHO DO FILE ARE 80% MORE LIKELY TO DIE THAN CANCER PATIENTS WHO DON'T FILE FOR BANKRUPTCY PROTECTION. AT CLC, WE SEE THIS STARK REALITY IN OUR CLIENTS' LIVES EACH DAY. BEHIND EACH ONE OF THESE STATISTICS IS AN INDIVIDUAL OR A FAMILY IN CRISIS. FINANCIAL TOXICITY AND THE STRESS IT BRINGS ARE OFTEN MORE LIFE-THREATENING THAN THE CANCER ITSELF.

(3) THE LACK OF ANY OTHER RESOURCE FOR THIS CRITICALLY NEEDED LEGAL CARE. IN 2025, THIS EQUATES TO A GROSS ANNUAL INCOME OF \$31,300 FOR A SINGLE PERSON AND \$64,300 FOR A FAMILY OF FOUR. IN 2025, 50% OF CLIENTS WERE AT OR BELOW 200% FPG, AND 22% WERE BETWEEN 200% AND 300% FPG. CONSEQUENTLY, CLC TAKES A DIFFERENT APPROACH GIVEN OUR CLIENTS' LEGAL NEEDS AND THE FINANCIAL FREEFALL IN WHICH THEY FIND THEMSELVES. PEOPLE ALL ACROSS THE INCOME SPECTRUM HAVE WORRIES AND QUESTIONS ABOUT LEGAL ISSUES THAT ARISE BECAUSE OF THEIR DIAGNOSIS AND TREATMENT. ACCORDINGLY, CLC PROVIDES LEGAL COUNSELING AND INFORMATION SERVICES TO ANYONE IN NEED REGARDLESS OF INCOME. ALL OF OUR SERVICES ARE PROVIDED FREE OF CHARGE. CLIENTS WHO NEED EXTENDED REPRESENTATION FOR FULL ESTATE PLANNING AND SOCIAL SECURITY APPLICATION NEEDS MUST MEET INCOME GUIDELINES. ADDITIONALLY, WE SERVE THE ENTIRE STATE WITH 24% OF OUR 2025 CLIENTS LIVING IN GREATER MINNESOTA AND 76% IN THE TWIN CITIES METRO AREA.

IN 2025, THE AVERAGE AGE OF CLC'S CLIENTS WAS 53 YEARS - IN THE PRIME OF THEIR WORKING, AND OFTEN, FAMILY-RAISING YEARS. ADDITIONALLY, 52% OF OUR 2025 CLIENTS ARE LIVING WITH STAGE IV CANCER. THE COMBINED EFFECT RESULTS IN AMPLIFIED CONSEQUENCES IF A CANCER SURVIVOR'S SPECIFIC LEGAL NEEDS REMAIN UNMET.
